Regarding Employees recruited on contract basis

284. Smt. Sarvjit Kaur Manuke, MLA:- Will the Chief Minister be pleased to state:-

- total number of employees alongwith the time recruited on contract basis under various departments w.e.f. April, 2004 to March 2019 in Punjab;
- the number of employees regularized out of the same togetherwith the time by which the remaining employees are likely to be regularized?

Regarding Shut Down of Factories in District Ludhiana

285. Smt. Sarvjit Kaur Manuke, MLA:- Will the Labour Minister be pleased to state:-

- the number of factories which have been shut down in all the constituencies of district Ludhiana from the year 2007 to year 2017, information of the same be provided respectively;
- whether there is any proposal under consideration of the govt. to open any new factory in Assembly Constituency Jagraon?

To make arrangements of drainage of sullage water of ponds

286. Shri Budh Ram, MLA:- Will the Rural Development and Panchayats Minister be pleased to state:-

- whether it is a fact that sullage water remains accumutlated in ponds in many villages namely Gurne Kalan, Guradi, Datewas, Chak Ali Sher, Akkan wali, Budhlada in Budhlada sub division and there is no arrangement of drainage of the same; if so, the details of such villages;
- whether there is any scheme under the consideration of the govt. for the drainage of sullage water of ponds of the villages mentioned in part (a) above; if so, the details thereof?

Upgradation of Middle Schools

287. Shri Budh Ram, MLA:- Will the Education Minister be pleased to state whether it is a fact that already 6 posts are sanctioned in middle school and only 2 posts are required to upgrade it to High School ; if so , whether there is any Scheme under consideration of the Govt. to upgrade the middle schools of Punjab to High Schools; if so, the time by which it is likely to be done?

Filling up of vacant posts

288. Shri Budh Ram, MLA:- Will the Higher Education Minister be pleased to state whether it is a fact that a University College is functioning at village Bahadurpur of sub-division Budhlada; if so, the number of sanctioned posts togetherwith the number of those lying vacant thereat alongwith the time by which the said posts are likely to be filled up?

Construction of road at Bareta

- whether it is a fact that the Public Works Department has floated tenders for construction of road at Bareta; if so, the name of the company to whom the said tender has been given togetherwith the time by which the said work is likely to be accomplished;
- whether it is also a fact that the work of the aforesaid road is lying suspended for quite sometime; if so, the reason for its remaining stalled togetherwith the time by which the same is likely to be resumed?

To rectify the Sign Boards of the Villages

290. Sardar Kultar Singh Sandwan, MLA:- Will the Public Works (B & R) Minister be pleased to state whether it is a fact that sign-boards of villages falling on Faridkot-Bathinda highway are wrongly installed; if so, the time by which these are likely to be rectified?

To give ownership rights according to "Lal Dora"

- whether their ownership is acknowledged on the basis of water, electricity or sewerage connections;
- whether according to revenue record the govt. intends to give ownership rights to the people living in the "Lal Dora" area of urban areas in the state?

- whether it is a fact that ownership of the aforesaid is considered on the basis of water, power or sewerage connections only;
- whether the govt. intends to provide legal ownership right to the people residing in Lal Dora areas in Punjab as per the revenue record?

- whether the Govt. is taking concrete steps to check the encroachment on Govt. land in future; if so, the reasons therefor?
