Sanctioned posts in Punjab Powercom and PSTCL

520. Shri Pawan Kumar Tinu, M.L.A.:- Will the Chief Minister be pleased to state:-

- (a) the number of sanctioned posts which have been abolished by the Punjab Govt. from year 2017 to-date in Punjab State Power Corporation Limited (POWERCOM) and P.S.T.C.L. (Transmission) or there is any proposal to abolish the same together with the reasons therefor together with the number of posts of Scheduled Castes and Backward Classes in the abolished posts;
- (b) the number of employees of Punjab Ex-Servicemen Corporation working on outsource in Power Com and P.S.T.C.L. (Transmission) out of the posts so abolished;
- (c) the number of new posts created as well as recruitments made togetherwith the number of candidates who are from Punjab as well as from other states out of recruited candidates;
- (d) the number of sanctioned posts lying vacant at present together with the time by which said vacant posts are likely to be filled up?

- (b) if reply to part (a) above be in the affirmative, whether there is any proposal under consideration of the Govt. to conduct investigation and take due action against the dealers selling aforesaid adulterated pesticides and the officers of agriculture department, in whose areas such pesticides are sold; if so, the details thereof?

Details of revenue collected from year 2002 to 2020

- b) as to why the Secretary, Punjab Government Education department did not take any step against this negligence of the School authorities and kept on delivering his speech while the students sitting on the ground were shivering with cold?

Construction of Bridge over the drains of Budhlada villages
