#### To submit Report of Justice Gurnam Singh Commission

237. 1. Sardar Gurpartap Singh Wadala, M.L.A.)

2. Sardar Kanwar Sandhu, M.L.A):-Will the Chief Minister be pleased to state:

whether it is a fact that four Sikh youths were killed during firing by the police while showing resentment against sacrilege and burning of 5 Saroops of Sri Guru Granth Sahib ji at Nakodar (district Jalandhar) in the year 1986 and dead bodies of these youths were cremated by the police, against the orders of the govt.;

whether it is also a fact that Justice Gurnam Singh Commission was constituted on 5<sup>th</sup> February, 1986 by the Punjab Govt. to conduct enquiry of this matter, which had submitted its report to the govt. on 29<sup>th</sup>March, 1987;

if reply to part(a) and (b) above be in the affirmative, the copy of report of Justice Gurnam Singh Commission be laid on the Table of the House?
