" The tragic massacre of innocent protestors in Jallianwala Bagh in Amritsar on 13<sup>th</sup> April 1919 remains one of the most horrific memories of British colonial rule in India.

This shameful military action against locals peacefully protesting against the oppressive Rowlatt Act has since received worldwide condemnation. However, its proper acknowledgement could only be by way of a formal apology by the British Government to the people of India as we observe the Centenary of this great tragedy.

This august House thus unanimously recommends to the State Government to take up this matter with the Government of India to impress upon the British Government to officially apologize for the massacre of innocent people at Jallianwala Bagh, Amritsar.".
